



#### ESSENTIAL RTA ADVOCACY

The Regional Transit Authority Advocates Coalition (RTAAC) provides a strong, unified voice for transit users in the 15 RTA service areas across Massachusetts.

RTA advocacy is essential:

- 55% of MA residents live in an RTA service area
- RTAs connect communities to opportunities that shape quality of life
- Low-income families, older adults and people with disabilities disproportionately rely on RTA services
- RTAs are a lifeline during the COVID-19 pandemic





# HOW ARE RTAs FUNDED?

ON AVERAGE, RTAS RECEIVE OPERATING FUNDING FROM THE FOLLOWING:

**39**% from the state

24% federal grants


20% local funds

13% fare revenues

4% other sources

#### **OPERATING FUNDS FOR REGIONAL TRANSIT AUTHORITIES**

RTA operations are funded through a combination of state and federal funding, local assessments, and fare revenue.<sup>9</sup>
Each RTA's budget breaks down differently.



#### RTA FUNDING CHALLENGES




Unpredictable and unstable funding for RTAs has resulted in poor service planning. **RTAs** implement an improvement to service Cuts / RTAs unable insufficient to sustain increase in service RTA state improvement funding

INADEQUATE STATE FUNDING AND LIMITED TECHNICAL SUPPORT MAKE IT CHALLENGING FOR RTAS TO MAINTAIN SERVICE LEVELS AND EXPAND TO MEET THE NEEDS OF

RIDERS.

- Most RTAs cannot afford a late-night service
- Some RTAs do not run on Sundays or even on weekends
- Geographic boundaries of the 15 RTAs limit rider mobility
- Many rural communities are unserved or marginally served
- Most RTA buses run on diesel fuel, which contributes to air pollution
